#### Unfinished business

- 1) CTHA needs copies of the SPS contract.
- 2) Tract 989 (common open space)-Lot 27 removed things from the common area, but lot 28 still has trees left in the NGPA and needs to remove the badminton set.
- 3) Lot 72 needs proof of on time payment last year or they will be fined

- 4) Landscaping-no add'l info. on scope of contract. Need to document each area/timing/tasks/etc.
- 5) Ron should get reimbursed \$114.15 for parts for the water spigot
- 6) Signs are completed and Ron will install them
- 7) CTHA is working issues with requests for clarification on landscaping issues.
- 8) Form letters were sent for parking and other issues
- 9) Comments re. ensuring that the ACC is part of future landscaping audits if at all possible
- 10) Trees on 200<sup>th</sup> Place will be trimmed by landscaper to specified dimensions, but homeowners need to ensure those dimensions are kept up in the future. Recommendation to take a picture of the street/trees after completion.
- 11) Follow up on the trees in the front-1<sup>st</sup> bid is in for the 8 bad trees. Bid is too expensive currently for the CTHA budget. Suggest getting new bids for the 2-3 worst trees to be brought up properly or replaced with new trees.

#### New business.

- 1) Brian will supply the list of possible liens including prior amounts/fees/interest due along with the current annual amount due.
- 2) There are currently 12 unpaid assessments heading toward a lien, but we are not at the deadline yet. The delivery confirmation process for these items needs to be improved.
