9. ST followed up for RL. ST received quote for removal of 5 and 6 of the most hazardous trees from Blue Ribbon. Option to save money by removing downed logs via community work party discussed. AI complete.

10. ST will follow up to request work be done by premier to fix timbers in Tot Lots. **Done.** 

11. ST to provide information as possible as to whether it is possible for the HOA to obtain monies owed once lot that is bank owned is sold by its new owner, REO NW. ST will look up lender and board may choose to contact bank directly based on that information.done-REO agreed to pay \$529 of the balance, and the remainder is now uncollectible.

### II. Budget and Finance Report

**Review of Financial Position** 

The following statements have been internally prepared and reflect accrual accounting.

Balance Sheet for April 30, 2011

The balance sheet shows the Association's financial position on the 31st of March this year. The checking account cash balance is \$15,999.90 plus \$10,250.66 in reserves plus \$3,801.36 in receivables for a total of \$30,051.92.

CG made a motion to accept the financial report and DM seconded; passed unanimously.

#### III. Management Report

A.Homeowner called to voice concern regarding fence painting at retention pond. RL to follow up and plan work party.

B.One lot is facing foreclosure by owner report. Owner is on a payment plan for past dues owed, and stated he would make last payment in June.

C. \$529 collected from REO for the bank owned lot. RL moved to write off the remaining \$510 as it is uncollectible at this time. DM seconded. Motion passed.

D. Question posed at to status of liens on lots that have delinquent dues. ST to research current liens and report to board.

## IV ACC Report:

a. Lot 4 requested approval for hardy plank and paint colors, and ACC approved.

#### V. Ongoing Business

a. Arborist report and tree removal. ST received and distributed to the board bids for removal of worst 5-6 trees. Board requests additional bid for purpose of comparison.

Board will discuss at annual meeting the options of using a community work party vs. haul away service for the downed trees.

a. A drafting of the spring newsletter is available for BOD review. BOD will review via email, and then RL will distribute with help from volunteers.

b. Annual meeting planning. Board plans to provide a sign in sheet for annual meeting to allow homeowners who would like to share or ask questions to be recognized in an efficient and orderly fashion.

- 7. ST to obtain second bid for removal of 5 most hazardous trees for price comparison.
- 8. RL to speak to Blue Ribbon.
- 9. ST to check lien status on 2 lots (#46 and #44) and report to the board for consideration of updating or initiating lien if necessary.
