ST getting quote from landscapers for Dec 2014 meeting. -- Bid received from Premiere Lawn Service. --- JB made a motion to postpone replanting until spring. CM seconded. Approved unanimously.
- **C.** Tot lot wood treatment JE is getting recommendations for treatment. Getting info from manufacturer on proper maintenance. -- Treatment not necessary this season. BOD will re-evaluate cleaning and treating tot lots in Summer 2015.
- **D.** ST is looking into using Wells Fargo Bank for all HOA banking accounts. -- ST requested reserve documents from Wells Fargo Bank. --- JE made a motion to move the reserve account funds to Well Fargo Bank for better money management. CM seconded. Passed unanimously. ---- BOD is waiting for the current CD to mature before changing accounts.
